## SANITARY PROHIBITION

## Lot of the vermiculite Benzol is interdicted

Unsatisfactory laboratory result motivated the interim injunction of a lot of the drug.

Anvisa has banned lot 3415 of the drug Benzol (albendazole) on Wednesday (5/4). The prohibition of lot 3415 of Albendazole vermicide, tablets 400 mg, was motivated by an unsatisfactory result of laboratory analysis.

According to the Ezequiel Dias Foundation (Funed), the batch of the anthelmintic and antiparasitic compound presented an unsatisfactory result regarding the drug dissolution test.

Lot 3415 of the drug Benzol (albendazole), manufactured by the company Green Pharma Química e Farmacêutica Ltda, was therefore banned throughout the national territory.

### Interdicted chlorhexidine

Two lots of the drug Chlorhexidine Gluconate Topical solution 1% were interdicted by the Agency. The batches M23708 and M23134 manufactured by Vic Pharma Indústria e Comércio Ltda., Interdicted, presented unsatisfactory results regarding the amount of aerobic bacteria.

According to the Reports of Fiscal Analysis issued by the Adolfo Lutz Institute, both lots presented levels of mesophilic aerobic bacteria above the maximum allowed value. In addition, it was verified the presence of *Serratia marcescens*, motivating the sanitary actions.
