1. Nature of non-compliance:

A general lack of ability to adhere to the principles of good manufacturing practices for production facilities, laboratory facilities and storage of reference and retention samples. Examples of non-adherence are: The production facilities were not appropriate for GMP use. There was a big risk of contamination of products. The whole facility was not in a protected and controlled environment. Also the laboratory facilities were not in a protected and controlled environment. Reference and retention samples were not stored in a controlled container. The personnel was not trained in EU GMP guidelines. As a result the quality of the product is not ensured.

Action taken/proposed by the NCA

Recall of batches already released


Based on a risk assessment and due to the general nature of the non-adherence issues observed we do not recommend recall of medicinal products already in the market at this point.
