
We supply MOH by; parental fluids , Antibiotic infusion vials , water for injection ,.....etc.

Warehouse Project

- It is not hard to imagine a standard warehouse, The drug's road from its manufacturer to the patient is easy only in theory. It requires solutions recording even smallest movement of goods, accelerating their circulation and increasing the precision of deliveries
- AlRazan upgraded it's main warehouse in 2014. This upgrade was done to comply with the regulation of Good Distribution Practices (GDP) to match with the European standards in pharmaceutical distribution.
- One of the advanced systems that have been used in the warehouse is the racking system with number for each location; this number is reflected on computers. We have had situations when drugs with shorter expiry dates were left on the shelf, while the ones with longer dates were shipped out. Our systems eliminated such errors, Installing data loggers to control temperature and humidity inside the warehouse ,in order to create suitable storage condition for our products. We also implement a control system to protect our warehouse from any Intrusion by Insects.



We in AlRazan believe that such as ambition, integrity, communications and collaboration had all got us where we are today. Our employees are encouraged to be active and collaborate with each others in order to get the job done





Distribution Management

Managing logistics activities , follow up through the sales team assigned to each branch demand activities.

Atabay Ilac , Turkey

Atabay was founded in Istanbul by Mr. Ö. Kemalett in Atabay, Pharmacist, in 1939, prior to the outbreak of the Second World War. The company had emerged as a trading business, importing and marketing pharmaceutical products. In the 1940's, this medium sized commercial operation developed into the production of sulfonamide tablets, which were in great demand at the time, thus paving the way to the pharmaceutical industry in Turkey. By 1954, Atabay Pharmaceutical Products Inc. had evolved into a well equipped modern plant. The initial product line expanded to include analgesics, apart from sulfonamides. Atabay's rapid growth, in due time, necessitated a larger plant. Consequently, in 1967, this facility was established at its present site in Acıbadem, Istanbul

After successful years of performance in pharmaceuticals, Mr. Bülent Atabay, Chemical Engineer and President, prompted back – integration and entered in to the manufacture of fine chemicals. In 1970, the site of Atabay

Pharmaceutical Fine Chemicals Inc was chosen at Gebze, near Istanbul. Five years later, in addition to the premises for the pharmaceutical fine chemicals, extensive facilities were set up in a separate area in Gebze to produce chemicals for the agricultural, public health and veterinary fields. Today, the Atabay enterprises, managed by a progressive and technically trained executive staff, is fully active in producing quality products for human and animal health. Marketing and promotion of the products are accomplished by a competitive sales network with distributors in the domestic as well as international arenas.
