BCN Peptides manufactures multi kilo batches of GMP Peptide using SPPS technology. We are specialists in long sequences and cyclic peptides.

Classified Area with 8 Independent rooms for preparative **HPLC**, with columns between 10 and 20 cm diameter. (and analytical in process control laboratory)

Classified Area with 11 independent rooms for the Lyophilisation of the final API Peptide.

Dedicated Classified Area with different rooms from grade **D** to grade **A**, for the manufacture of Sterile API Peptides, including Lyophilization and packaging under sterile conditions.

Water System:

Highly Purified Water produced by Osmosis. The Water loop is made in **PVDF** and is kept at low temperature

Classified Areas (HVAC System):

After the Chemical Synthesis all steps including Purification and Lyophilization are performed in Classified Areas, from grade **D** to **A**. The packaging is always performed under laminar flow hood grade **A** into a Classified Area.

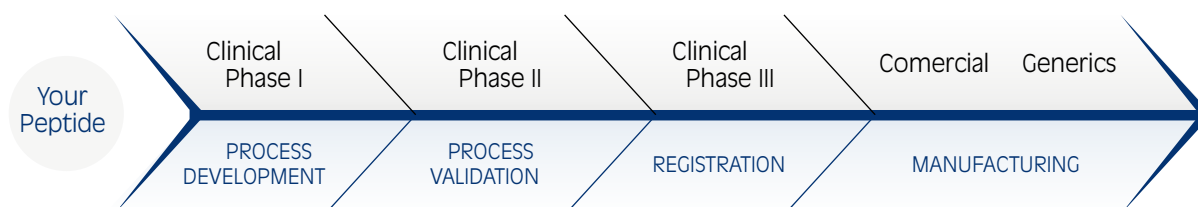
