### **Quality and Regulatory**

We observe an increasing quality and regulatory demand across the value chain in the pharmaceutical industry with growing emphasis on risk management, transparency and control. For our most important APIs (active pharmaceutical ingredients), Corbion holds the necessary pharmaceutical registrations (CEP, US-DMF, CA-DMF). Through continuous investment in Quality and Regulatory activities, we embed practices into our culture to improve business performance. cGMP (Good Manufacturing Practice) compliance to ICH (The International Conference on Harmonisation of Technical Requirements for Registration of Pharmaceuticals for Human Use) Q7 'Good Manufacturing Practice Guidance for APIs standards align Corbion with the concepts established by the ISO (International Organisation for Standardization). In addition, registration with European Union (EU) Regulation on REACH (Registration, Evaluation, Authorisation and Restriction of Chemicals) since 1 June 2007, and we successfully registered all substances that required registration before 1 Dec 2010 and before 31 May 2013 under Regulation (EC) No.1907/2006 (REACH). As well as the registration for the Biocidal Products Regulation (EU BPR 528/2012), effective from September 2013. This ensures Corbion is compliant within the particularly stringent European market.

#### **Parenteral and Dialysis**

Corbion produces pharmaceutical grades of Natural L-Lactic acid/(S)-Lactic acid and its derivatives, such as sodium (S)-lactate, which is sold as PURASAL S/PF®, for parenteral applications. sodium (S)-lactate functions as electrolyte or as an alkalinizing agent in these kind of applications. Calcium Gluconate is used in human injectable applications to prevent acute hypocalcaemia, and in veterinary applications, to prevent milk fever in cattle, for example.


