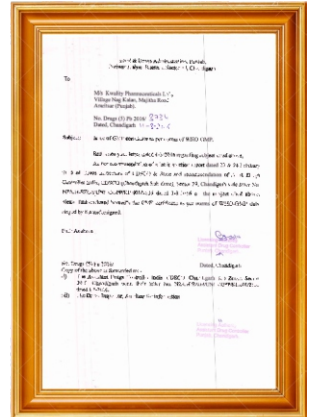
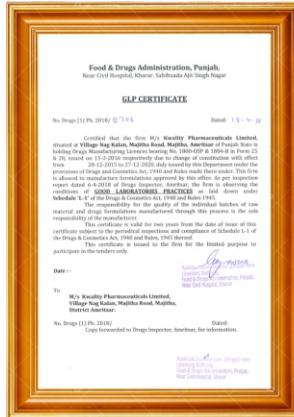
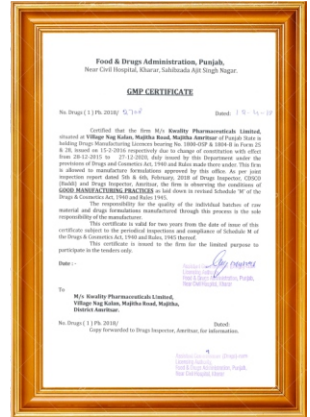
History of Directors

Source of Funds

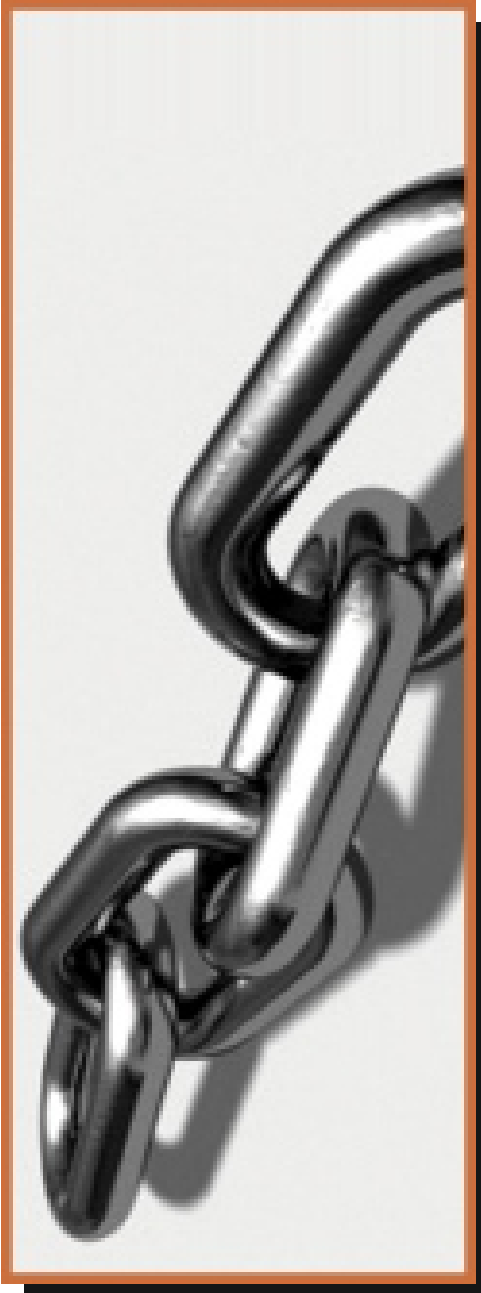
The company have extensive limits in banks. The company can also raise funds from capital market by IPO. The company is member of Bombay Stock Exchange.

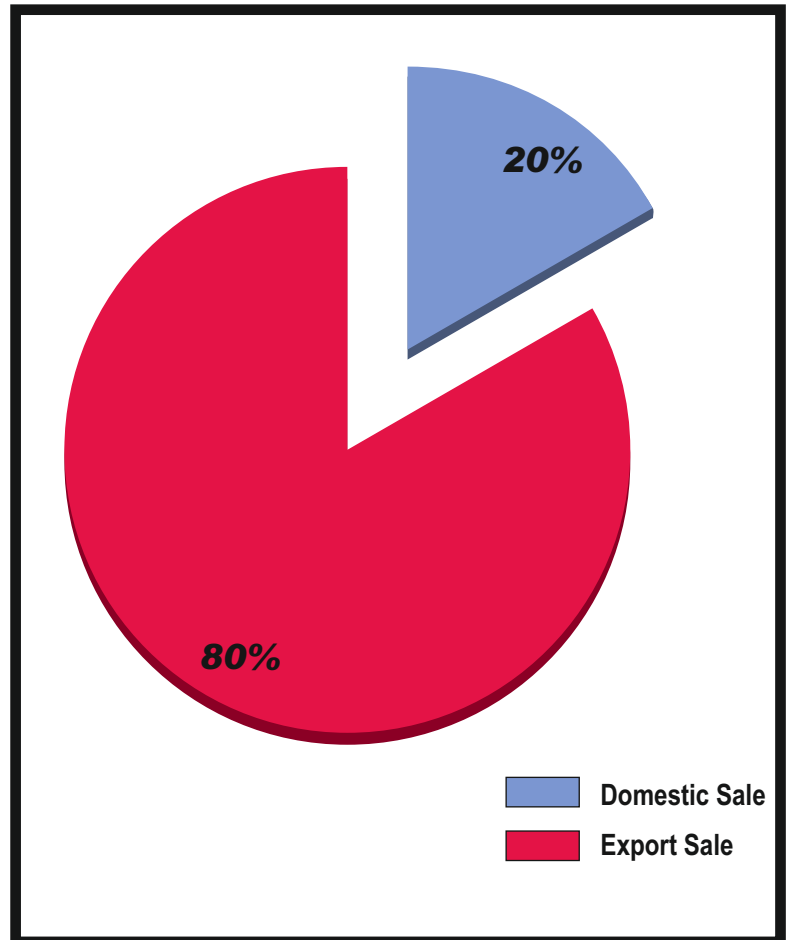
