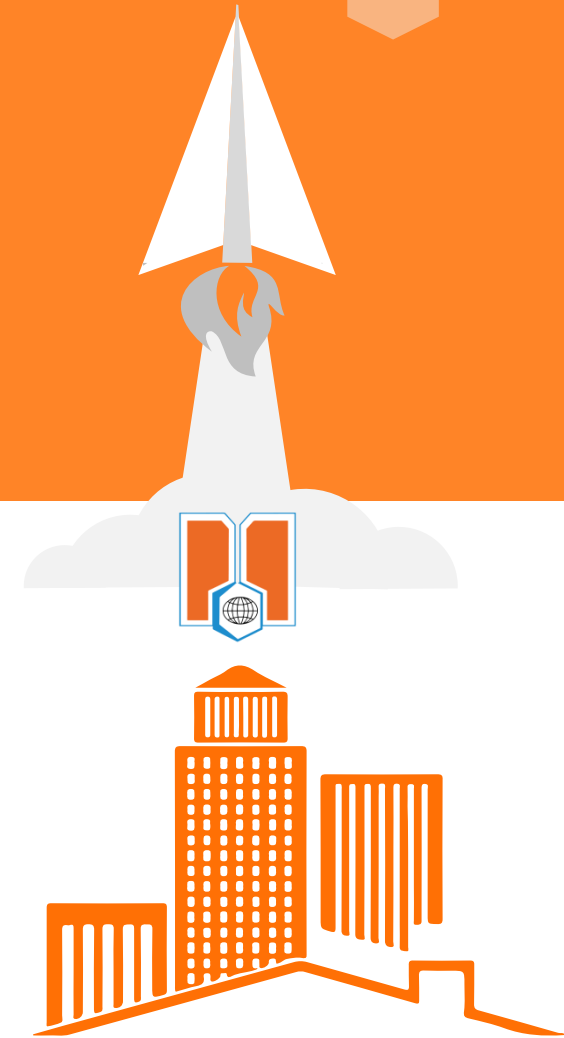

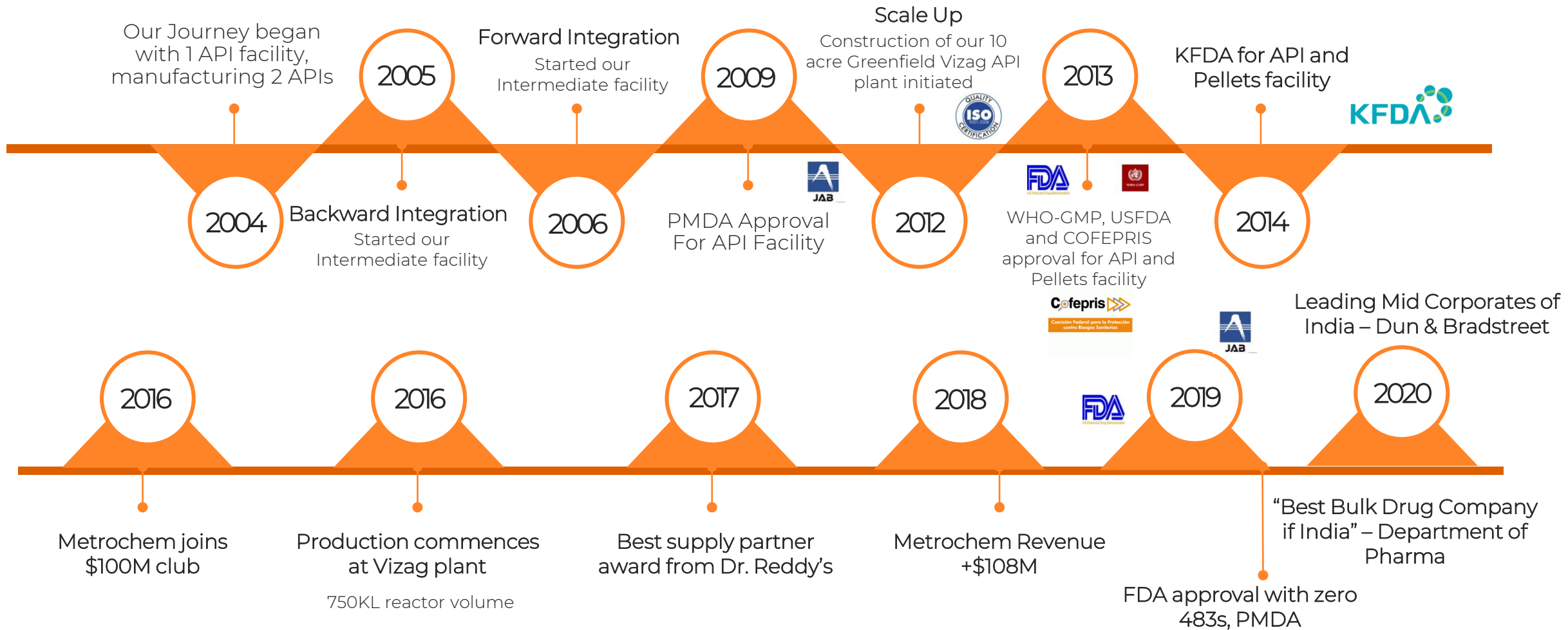

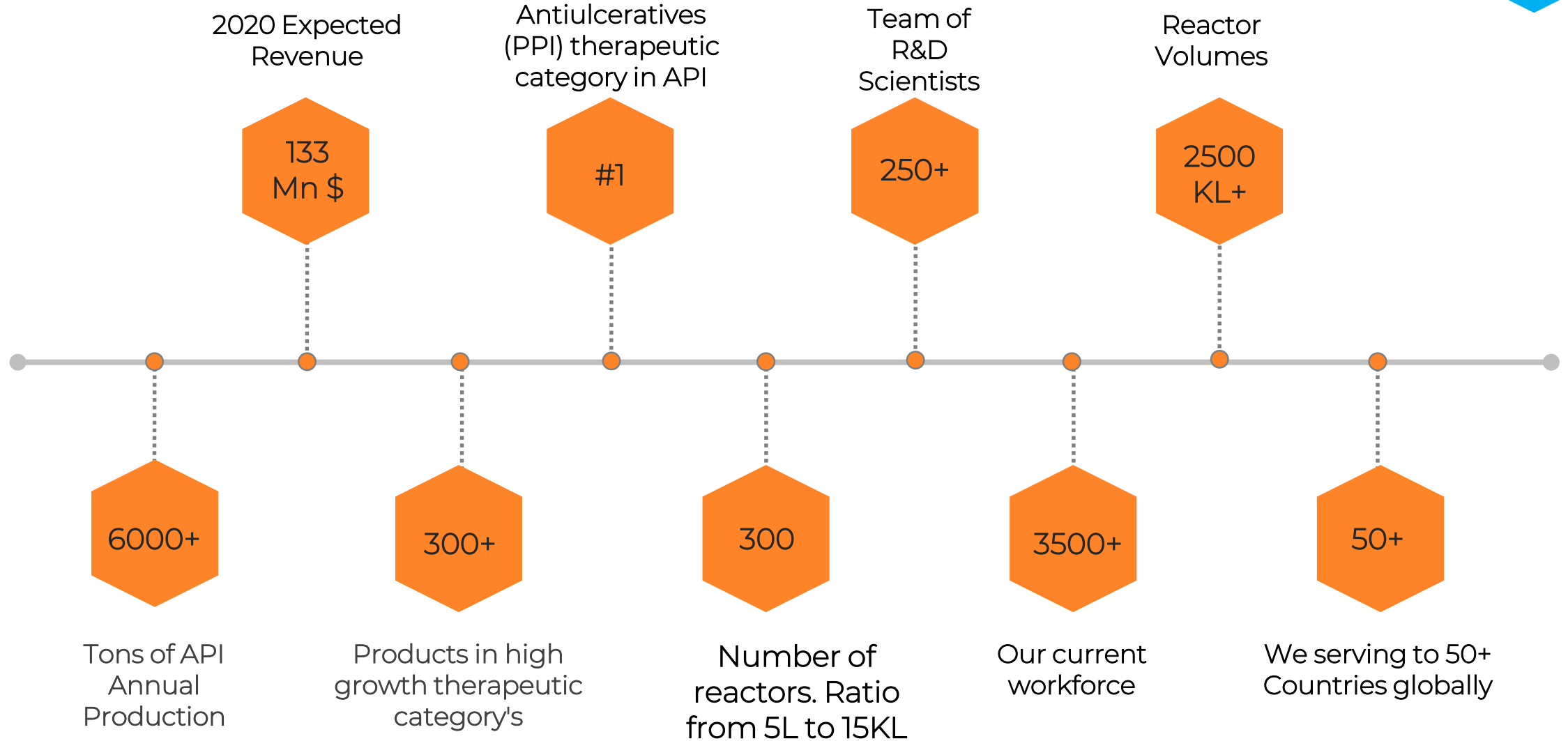
Metrochem Roadmap from 2004

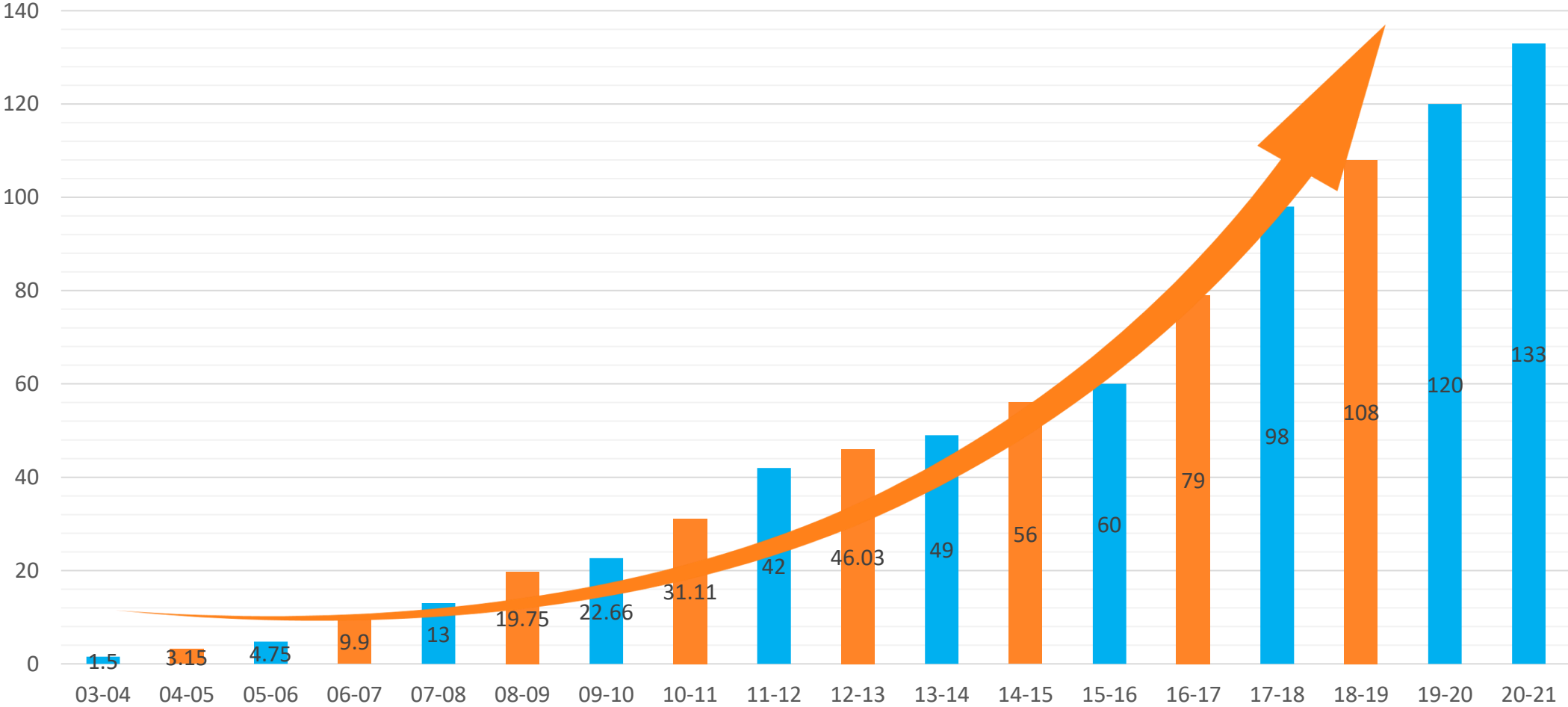

Revenues in USD Million

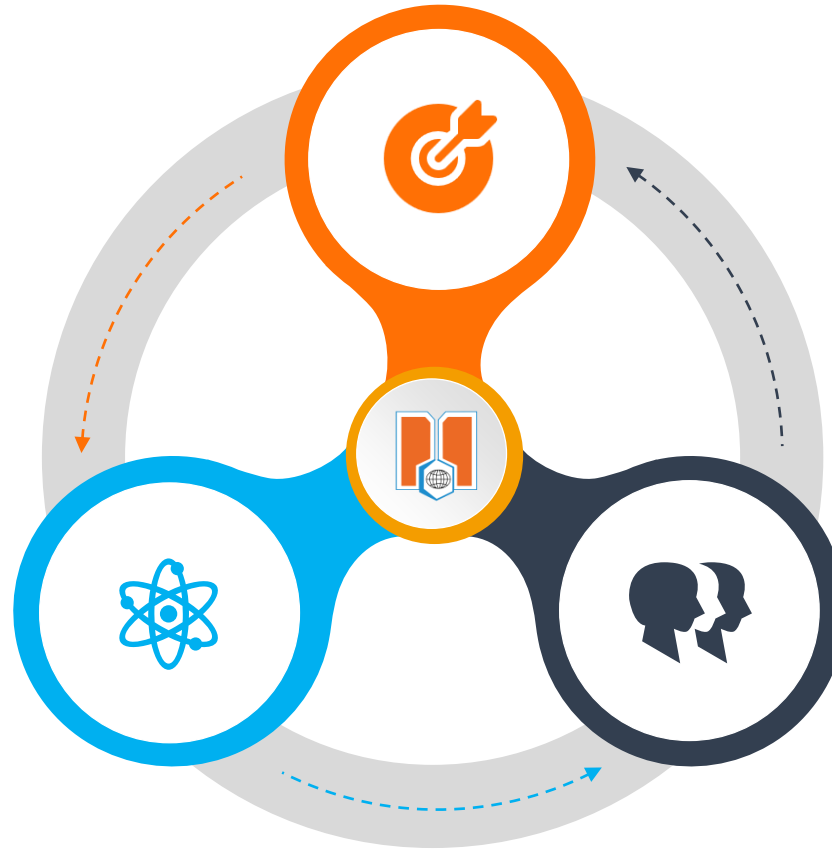

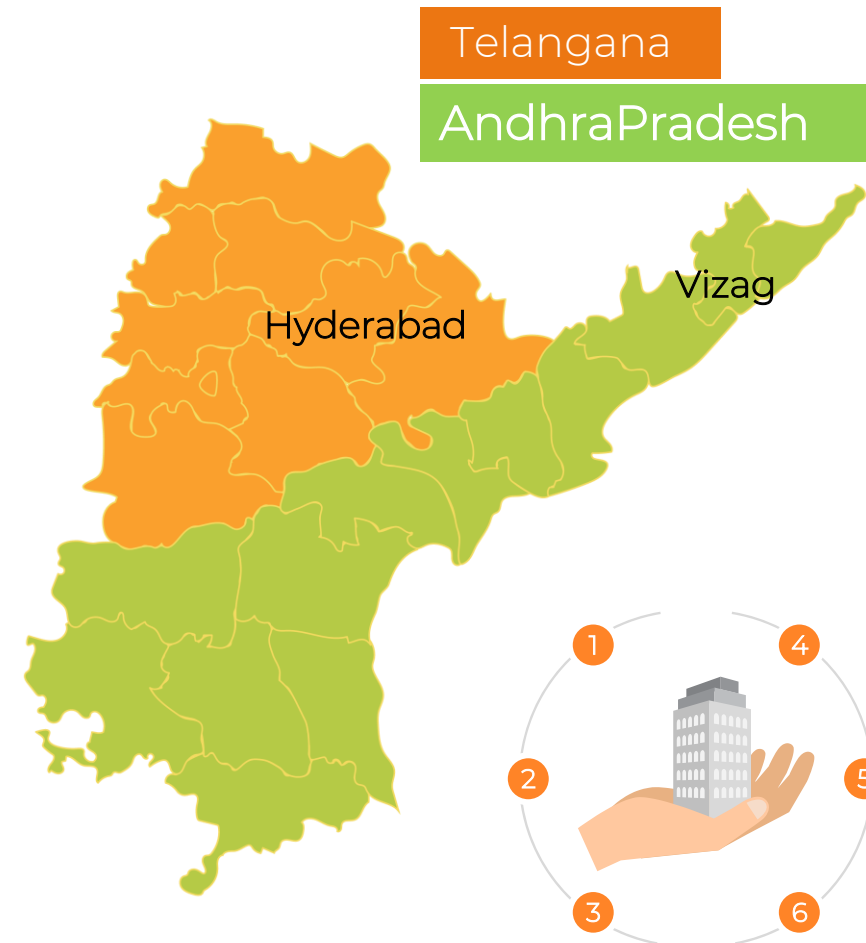

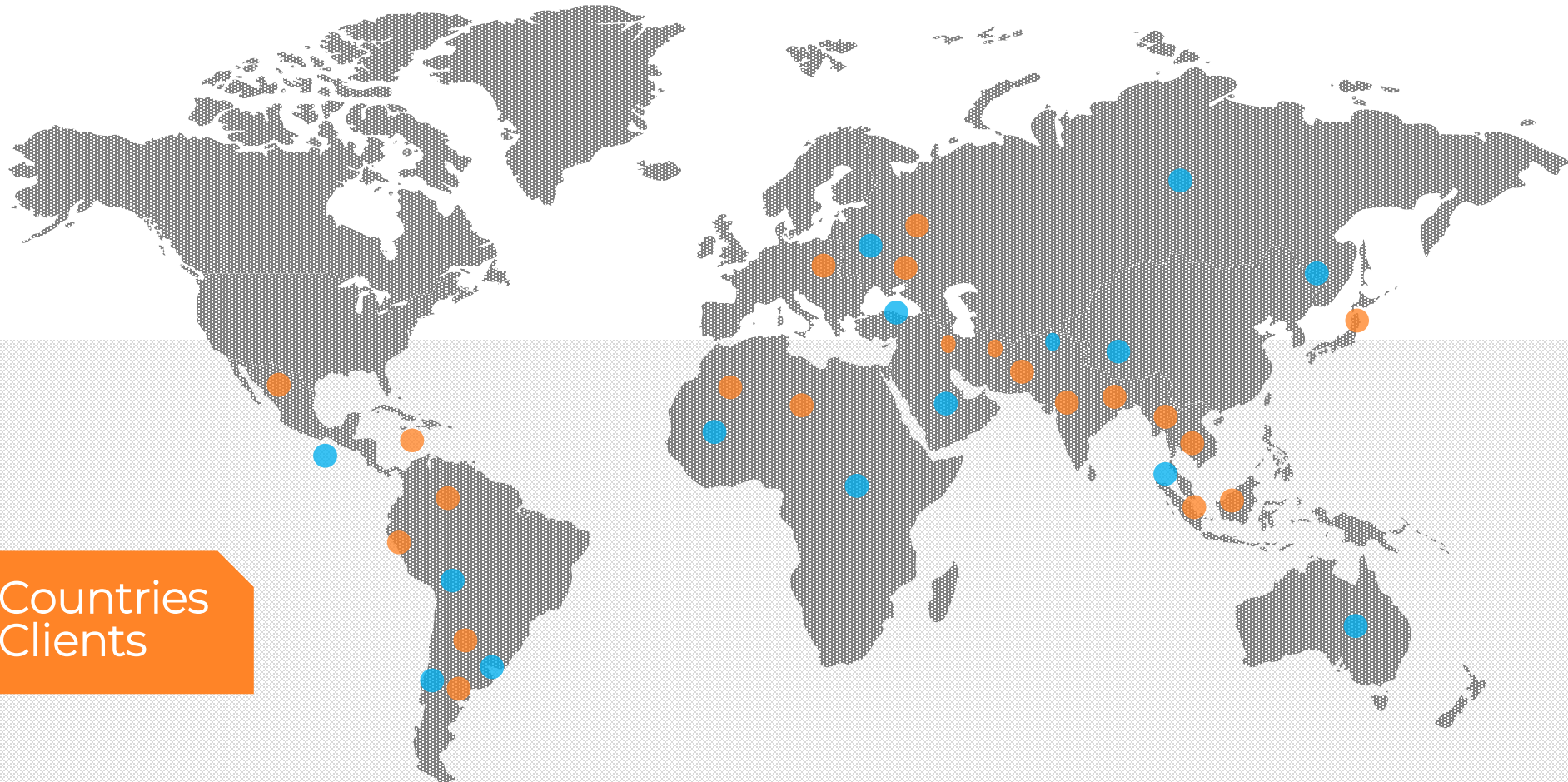
