Priyans has warehousing facilities in Singapore. Priyans also has distribution facilities in india to service global markets.

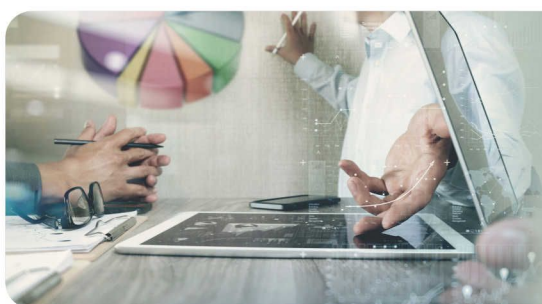
