

## **Products**

Specializing in consistent, high volume production, Sequoya is an end-to-end EU GMP certified extractor, mass producer & ultimately supplier of superior quality hemp extracts, concentrates and isolates to the biggest brands in the global cosmetics, food & beverage, nutraceutical & pharma industries.





### **CBD ISOLATES**

Sequoya's most popular product is CBD isolate and comes in fine powder form, completely odorless and crystal white colour and high stable compound. It's therefore extremely versatile in use across many consumer products; including, cosmetics, food & beverage, nutraceuticals and pharmaceuticals.

With greater than 99.8% purity, our hemp extract isolates (including CBD, CBG, CBC, CBN to name a few) are extracted using only clean technologies in a highly controlled EU GMP certified facility.

Purified to containing over 99.8% CBD, CBDa, CBG, CBC or CBN isolate that comes in a pure white crystalline or powder form, Sequoya's Isolates are derived entirely from European sanctioned industrial hemp strains.



#### **OIL CONCENTRATE**

Highly concentrated and averaging around 70% to 85% CBD while preserving the natural terpenoids and other plant compounds producing a clear gold CBD Oil.



#### FULL SPECTRUM OIL

Sequoya uses clean CO<sup>2</sup> SFE Extraction process to produce high quality full spectrum oils, which contains the full spectrum of cannabinoids, flavonoids and terpenoids naturally occurring in cannabis plant.



#### **HEMP TERPENES**

Terpenes, otherwise known as terpenoids, are volatile chemicals that emit a range of strong aromas which is captured for use in a wide range of consumer products.

Our EU GMP Certified facility employs the most advanced industry extraction methods and technologies along with a full scale state-of-the-art production laboratory. Sequoya delivers a wide range of hemp derived ingredients for consumer goods producers, resulting in consistent, non-psychoactive, food safe ingredients for mass distribution.



#### Supercritical CO<sup>2</sup> Extraction Technologies

Our extraction process uses the most advanced extraction equipment available and strictly based on solventless, supercritical CO<sup>2</sup> extraction methods enabling the cleanest possible plant extraction and obtaining a full plant cannabinoid profile.

Our extraction technology and processes are capable of both high-yield, ultra-high pressure supercritical extraction and gentler 'slow and steady' extraction using a subcritical extraction method for extracting the whole plants' cannabinoids & terpenoids.

Manufactured by the world leader in extraction equipment, Canadian based Vitalis Technologies, the equipment is made of 100% food safe materials and metals and fully GMP compliant build and software.



### Advanced Refinement & Production Methods

Based on the most advanced laboratory instruments & equipment at the Sequoya facility, we deliver a wide range of hemp derived products as ingredients for consumer goods manufacturers worldwide.

The entire facility was built from the ground up with the highest grade of materials conducive to producing for the food and pharma markets.

# **4 Quality Control & Analysis**







As an end-to-end EU GMP Certified facility, core to operation is our modern Analysis & Quality Control Area, staffed with Sr. R&D and Quality Specialists maintaining quality control and in producing consistent and highest quality results in mass volumes.



#### **Analysis Services**

Our Quality Control & Analysis Department conducts cannabinoid profile analysis across all forms of hemp and cannabis, including raw crude extract, purified oil concentrates, CBD isolates; as well as plant analysis of hemp biomass THC cannabis flower, and testing services for both consumer goods producers, pharmaceutical majors and universities across Europe.

#### Quality Assurance & Quality Control (QA/QC)

The QA/QC department guarantees consistent quality of all production across every stage of the technological process. Sequoya's QA/QC department analyzes and logs results across the entire stage and spectrum of our operations.

Measurements on quality and consistency are conducted from the biomass, through extraction, across the many stages in the laboratory in dewaxing, refinement, purification and final ingredient formulation results. This process enables Sequoya to deliver products to clients with exact predictability.



#### **Guiding Standards & Certifications**

Sequoya's operations are strictly standards based and fully certified. Namely, as an EU GMP Certified facility all stages adhere to the highest possible standards, including HACCP and fully Food Safety Compliant and Food Safety & Sanitation Certification (Chief Sanitary Inspectorate).

These standards are carried through utilizing only EU certified hemp strains with certificates of analysis. This assures our clients the standards required to use Sequoya products across all popular consumer applications.


