- •China's largest pharmaceutical manufacturer of bulk antipyretics and analgesics. The annual output for APIs is around 25,000 Mt. The major APIs include Levodopa, Trimethoprim, Ibuprofen, Caffeine, Theophylline, Hydrocortisone, Aspirin, metamizole sodium, propyphenazone etc.






#### **Certificate Granted**


## **Quality Policy**






