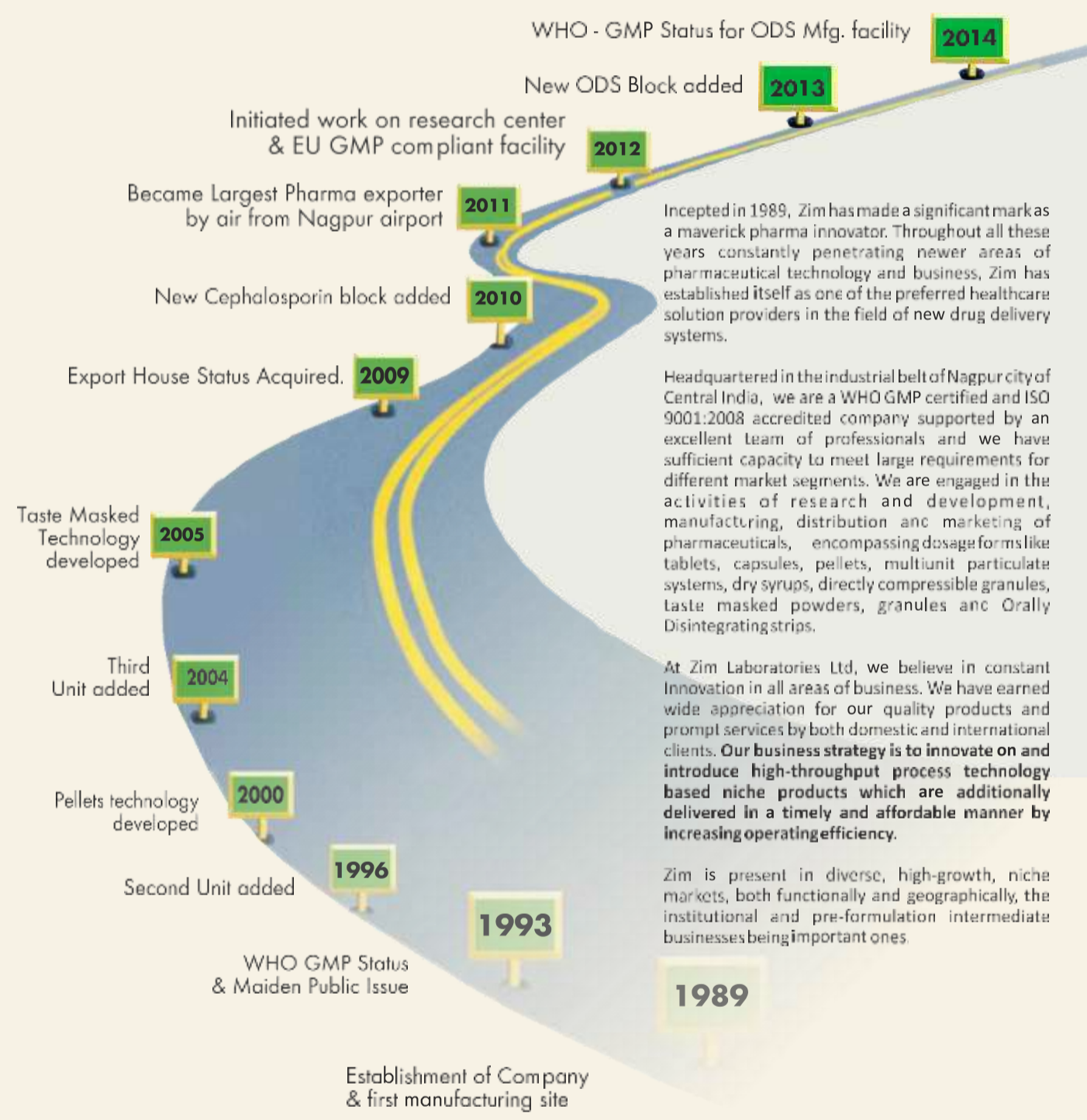

All our cGMP compliant and WHO GMP certified manufacturing facilities have faced several third party and buyer country MOH audits successfully and are capable of manufacturing wide variety of solid dosage forms like Tablets, Capsules, Pellets including dispersible and bi-layered tablets and Orally Disintegrating strips. We also produce Powders and Granules. A built-up area of more than 30,000 sq. meter contains capacity to manufacture about 4,800 million tablets, 1,000 million capsules and 500 Metric Tons pellets, tastemasked powders & granules annually.

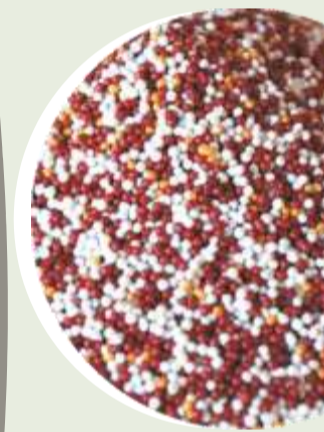
Quality Control

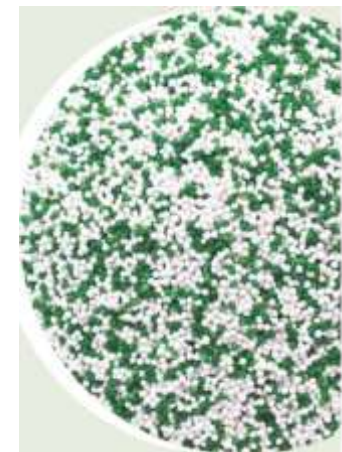
